









Experts, including the Centers for Disease Control and Prevention (CDC), Occupational Safety and Health Administration (OSHA) and World Health Organization (WHO), agree hand hygiene is one of the most important measures in preventing illness.

Gerba, show that approximately one in four soap samples taken from open refillable soap dispensers contained unsafe levels of bacterial contamination. Coliforms, illness causing fecal-based organisms, were found in 16% of the samples. No contamination was present in soap samples taken from sealed systems.

According to Dr. Gerba, the germs found in the open, refillable soap dispensers (those dispensers filled by pouring soap from a gallon jug into the dispenser) can cause serious infection in young people as well as immunocompromised individuals.










GREEN BASICS

How is "Green" defined?

The definition of Green comes from Presidential Executive Order 13101, which defines it as "products and services that reduce the health and environmental impacts compared to similar products and services used for the same purpose." A simple way to define Green is to think of it in terms of creating healthy environments to live and work in.

How is "Health" defined?

Health is defined by the first World Health Organization as the complete state of physical, mental and social well-being and not merely the absence of disease or infirmity. Therefore, health may be regarded as a balance of physical, mental, and social aspects of life in a being.

What is "Green Cleaning"?

Green cleaning is defined as cleaning that protects health without harming the environment.

How do you define "Green Building"?

Green Building is a process of design and construction that employs techniques to minimize adverse environmental impacts and reduce the energy consumption of a building, while contributing to the health and productivity of its occupants.

What are some of the benefits of going Green?

LEED CERTIFICATION

What is LEED? How do I learn more about getting my facility LEED Certified?

LEED is an acronym for the Leadership in Energy and Environmental Design. LEED is the Green Building Rating System™ developed by the U.S. Green Building Council (USGBC), a non-profit organization committed to expanding sustainable building practices. The USGBC mission is to promote buildings that are environmentally responsible, profitable, and healthy places to live and work.


What is LEED-EBOM?

LEED-EBOM is the term used to describe LEED for Existing Buildings: Operations & Maintenance. The LEED-EBOM rating system is the nationally accepted benchmark for building owners and operators to measure operations, improvements and maintenance.

How is hand hygiene included in LEED-EBOM?

LEED-EBOM includes a prerequisite for green cleaning. This means a building is required to have a green cleaning policy addressing effective cleaning with a focus on improving occupant health.

The LEED-EBOM Green Cleaning prerequisite requires the development of "strategies for promoting and improving hand hygiene, including both hand washing and the use of alcohol-based waterless hand sanitizers." GOJO GREEN HYGIENE™ Solutions is designed to help your building meet this requirement.

What is the program?

GOJO GREEN HYGIENE Solutions is an integral component of your facility's green cleaning policy and is designed to help you enhance the well-being of building occupants through a comprehensive approach to hand hygiene.

Why is the program being implemented?

Because **Your Company Name** is committed to the health and well-being of all building occupants. By encouraging good hand hygiene, and providing the tools that make it easy for occupants to follow good hand hygiene practices, we are able to create a healthier indoor environment and reduce associated healthcare costs. The use of PURELL also supports our company's pandemic preparedness plan and helps us meet the hand hygiene requirements for LEED-EBOM certification. How serious of a problem are germs in the workplace?

A study conducted at the University of Arizona shows that the average desk harbors over 10 million germs!²

- The average phone harbors 25,127 germs per square inch.
- The average desktop harbors over 20,961 germs per square inch.
- The average keyboard harbors over 3,295 germs per square inch.
- The average computer mouse harbors over 1,676 per square inch.

(Compare the above statistics to the average toilet seat, which has only 49 germs per square inch!)

Why focus on hand hygiene to attempt to stop the spread of germs?

Because experts agree that the majority of germs are transmitted by hands. The CDC recognizes that the most effective way to limit the spread of germs in the workplace is by practicing good hand hygiene.

Why an alcohol-based instant hand sanitizer?

Because it's often difficult to get to a location with soap and water, such as the restroom, during the day when building occupants are busy at their desks, in meetings or using common areas such as cafeterias, lobbies and copy centers. Studies show that hands are not washed as often as they should be. An instant hand sanitizing product makes good hand hygiene possible away from the restroom and does not require water or paper towels. Alcohol-based products are encouraged because they are recommended by leading health and regulatory bodies.



Why PURELL®?

PURELL is America's #1 instant hand sanitizer. It's the brand people know and trust, and it's effective. PURELL promotes well-being and kills 99.99% of the most common germs that may make you sick.

Who will participate in the program?

All Your Company Name building occupants are encouraged to participate in the program

When will the program begin?

The program begins **DATE/TIME** and continues indefinitely.

How does PURELL work?

Very simply and effectively. The active ingredient in PURELL is ethanol, also known as "Mother Nature's disinfectant," a renewable resource derived from plants. The ethanol in PURELL causes the germs on your hands to break down, die and then fall off your skin. And after the germ-killing alcohol evaporates, the emollients help your hands feel soft and refreshed.

Doesn't PURELL dry out your hands?

It's not drying or irritating.

Doesn't PURELL kill good germs as well as bad germs?

PURELL does eliminate some of the good germs while it gets rid of the bad germs. The same is true when washing with soap and water. However, in both cases, your body quickly regenerates the good germs. So, rest assured. There is no harm from using either regular soap and water or PURELL.

I don't believe hand sanitizers work.

Research shows hand sanitizers, like PURELL, greatly reduce the spread of infection in our hospitals and reduce absenteeism in our schools and in the workplace. Hand hygiene is recognized by the CDC as the single most important means of preventing the spread of infection. However, this is a voluntary program.

Where has PURELL's efficacy been tested?

PURELL's efficacy has been extensively tested and validated in several different environments. Here are a few of those settings and their corresponding outcomes:

- Military setting: >40% reduction in lost training time²
- Hospitals: 36% reduction in infection rates³
- Corporation: 21% reduction in absenteeism due to illness⁴
- Elementary Schools: 50% reduction in absenteeism due to illness when combined with a hand hygiene education program⁵

Aren't sanitizers creating a superbug?

No. Alcohol does not build superbugs. There is NO evidence or clinical documentation supporting this. After PURELL kills germs, it evaporates quickly and completely, leaving no opportunity for germs to adapt. In fact, the use of PURELL is proven to be an effective means of greatly reducing the spread of germs.

The FDA had an independent panel of medical experts in 1997 review the available data on bacterial resistance due to antibacterial wash products. The conclusion: no link between the use of the products and bacterial resistance. If antibacterial soap isn't causing antibacterial resistance, then what is? Most likely, America's overuse of antibiotics.⁶
